




Define

Step one on your Net Zero journey is defining the organisational and operational boundaries of your company.




Baseline Assessment

If you can't measure it, you can't manage it. That's why you need to assess the Greenhouse Gas (GHG) emissions from your company's operations, also known as your **carbon footprint**.

Using the emissions categories and organisational boundaries defined in step 1, we'll guide you through where and how you can gather data from your operations and use publicly available **emissions factors** to calculate to your baseline **carbon footprint**.

We've also curated a list of resources to assist you in this process, including free data models, tools and survey to establish the commuting habits of your staff.



Engagement

When it's done right, engagement fosters a commitment to sustainability among your employees and stakeholders. This step is about creating an inclusive environment where everyone is encouraged to contribute to the Net Zero goal. Through active engagement and open communication, you'll build a collective sense of responsibility and enthusiasm for the sustainability initiatives ahead.



Solutions & Goals

By this point, you'll be ready to set long-term goals and short to medium-term solutions targeting your biggest impacts, and using an assessment of your risks & opportunities to go for the 'low-hanging fruit'. Your goals should be specific and measurable reductions in CO2e emissions. Best practice is setting both absolute and intensity targets, this involves looking at the opportunities for reducing emissions across your operations and setting targets that are both ambitious and achievable. The goals you establish here will guide the actions you take; ensure they are aligned with your overall vision for sustainability.



Implementation






Continuous Improvement
